\_\_\_ I have participated in the Diamond Therapy Level 1 calls where I can discuss my questions about Diamond Therapy with my peers and mentor.

\_\_\_ I have practiced Diamond Therapy in at least 30 Sessions (or more as required to gain proficiency), given to at least 8 different people (can include up to 3 pets), practicing the Level 1 procedures and techniques. (Level 2 Gemstone Therapy Practitioners need a minimum of 20 sessions with at least 4 different people/pets.)

\_\_\_ I have recorded session notes on the Level 1 Diamond Practice Session Forms, and submitted at least 10 (5 for Gemstone Practitioners) of these Practice Session forms to my Diamond Therapy mentor for review and feedback.

\_\_\_ I have discussed my Practice Session forms with my mentor.



\_\_\_ I have performed and notated at least 10 self-therapy sessions, submitting at least three to my mentor. Five or more of these sessions involved holding the Therapy Diamond, and five or more involved applying the Diamond on a therapy wand.

\_\_\_ I have received at least 5 Volunteer Feedback forms from at least 3 people and I have submitted anonymized copies to my mentor. (Gemstone Practitioners do not need to submit Volunteer Feedback forms but are encouraged to submit testimonials.)

## FINAL REVIEW

\_\_\_ I have performed one 20- to 30-minute Level 1 Diamond Therapy session for the proficiency portion of the Level 1 exam. This session has been video recorded and submitted to my mentor, performed in person with my mentor observing, or performed live via webcam.
